 - a) If the Data Owner does not provide complete details within grace period mentioned in the notification or
 - b) If the request received from the Data Owner entails arbitrary use of his/her right to know.

3. Your request will be processed for free of charge.

Please note that you have the right to complain to Bahrain Personal Data Protection Authority if our response is unsatisfactory.
